## What is "Planned Giving"?

Planned giving provides for *a future* gift to a charity, such as The Thurman Brisben Center, through your financial and estate documents. The simplest form of planned giving is a bequest, that is a gift of cash or other personal property, described in your will or trust instrument to be given to specific individuals and/or organizations.

You can also designate The Brisben Center as one of the beneficiaries of your retirement plan, IRA account, life insurance policy, bank accounts or other financial assets. It is essential that you consult with your tax and/or legal advisor about your individual tax and financial situation.

#### How do I make a 'planned giving' bequest to The Thurman Brisben Center?

Since you will need a Will and possibly other legal documents that describe who should receive your estate following your death, you should contact your attorney and your



financial advisor to discuss your intentions. We will be pleased to provide additional information about our organization that you or your advisors may require.
